Local Law No. 3 of the year 2024

A local law Providing a Four-Year Term for the Elective Office of Town Highway Superintendent of the Town of Russell.

Be it enacted by the Town Board of the
(Name of Legislative Body)

Town of Russell as follows:

WHEREAS, the term of office of the Town Highway Superintendent is currently a two-year term, and

WHEREAS, the members of the Board of the Town of Russell have determined and agreed that it is appropriate and necessary to change such term of office from a two-year term to a four-year term, and

WHEREAS, Section 23(2)(e) of the Municipal Home Rule Law of the State of New York authorizes the adoption of a Local Law subject to mandatory referendum changing the term of office of Town Highway Superintendent from a two-year term to a four-year term.

NOW, THEREFORE, be it resolved as follows:

Section 1. The term of office of Town Highway Superintendent of the Town of Russell shall be changed from a two-year term to a four-year term. Such four-year term shall commence on the first day of January following the first biennial town election after the effective date of this Local Law.

Section 2. At the biennial Town election next following the effective date of this Local Law, and every four years thereafter, the Town Highway Superintendent shall be elected for a term of four years.

Section 3. This Local Law shall supersede in its application to the Town of Russell, Section 24 of the Town Law with respect to the term of office of the elective Town Highway Superintendent.

Section 4. This Local Law shall be submitted for approval to the electors of the Town of Russell at the next general town election to be held on November 5, 2024.

Section 5. Any other local law, ordinance or resolution inconsistent herewith is hereby repealed.

Section 6. This Local Law shall take effect immediately upon filing with the New York Secretary of State after approval by a majority of the electors voting thereon in accordance with the requirements of Section 27 of the Municipal Home Rule Law.




