Be it enacted	by the Town Board (Name of Legislative Body)	of the

Title: This Local Law shall be known as the "Town of Russell Responsible Budgeting Law".

Whereas, the State of New York has passed a property tax cap establishing a limit on the annual growth of property taxes for local governments; and

Whereas, General Municipal Law Section 3-c(5) permits a local government to adopt a budget that requires a tax levy greater than that set by the State; and

Whereas, it is anticipated that in order to have responsible government and finances to retain the necessary services, it would be in the Town of Russell's best interest to enact such Local Law so as to permit, if necessary, to require a tax levy greater than the tax levy limit calculated pursuant to applicable New York State Law.

Therefore, it is hereby resolved that the Town Board of the Town of Russell is hereby authorized to exceed the tax levy limit imposed by the State of New York for the Town of Russell upon a vote of sixty percent (60%) of the total voting power of the Town Board, and authorizes the Town, after completing all required procedures for the adoption of a budget, to adopt a budget that requires a tax levy that is greater than the tax levy limit calculated pursuant to Section 3-c of the General Municipal Law.

Effective Date: This Local Law shall be effective upon the date of filing with the Secretary of State pursuant to Section 27 of the Municipal Home Rule Law.
