Local Law No. 1 of the year 2014

A local law overriding the tax levy limit for the Town of Russell and authorizing the adoption by the Town of Russell for a budget that requires a tax levy that is greater than the tax levy limit.

Be it enacted by the Town Board of the
(Name of Legislative Body)

Town of Russell as follows:

Title: This Local Law shall be known as the “Town of Russell Responsible Budgeting Law”.

Whereas, the State of New York has passed a property tax cap establishing a limit on the annual growth of property taxes for local governments; and

Whereas, General Municipal Law Section 3-c(5) permits a local government to adopt a budget that requires a tax levy greater than that set by the State; and

Whereas, it is anticipated that in order to have responsible government and finances to retain the necessary services, it would be in the Town of Russell’s best interest to enact such Local Law so as to permit, if necessary, to require a tax levy greater than the tax levy limit calculated pursuant to applicable New York State Law.

Therefore, it is hereby resolved that the Town Board of the Town of Russell is hereby authorized to exceed the tax levy limit imposed by the State of New York for the Town of Russell upon a vote of sixty percent (60%) of the total voting power of the Town Board, and authorizes the Town, after completing all required procedures for the adoption of a budget, to adopt a budget that requires a tax levy that is greater than the tax levy limit calculated pursuant to Section 3-c of the General Municipal Law.

Effective Date: This Local Law shall be effective upon the date of filing with the Secretary of State pursuant to Section 27 of the Municipal Home Rule Law.

I hereby certify that the local law annexed hereto, designated as local law No. ___ of 20__, of the City of _____ having been submitted to referendum pursuant to the provisions of Section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on _____, 20__, became operative.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as local law No. ___ of 20__, of the County of _____, State of New York, having been submitted to the electors at the General Election of November ____, 20__, pursuant to subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.
