SECTION 2. The Town Clerk is hereby instructed to file a certified copy of this Local Law in the principal office of the State Office Building Code Council, Division of Housing and Community Renewal, at the Two World Trade Center, New York, New York 10047.

SECTION 3. This Local Law shall take effect upon its being duly filed in the Office of the Secretary of State and in the Office of the State Comptroller.


