Pursuant to Real Property Tax Law Section 467, the following schedule of exemption income eligibility level and assessment reduction for person 65 years of age or over:

annual income	exempt amount
0 - 8,000	50%
8,001 - 8,999	45%
9,000 - 9,999	40%
<u>10,000 - 10,999</u>	35%
11,000 - 11,899	30%
11,900 - 12,799	25%
12,800 - 13,699	20%
