Financial Report

-Details of all income and expense transactions have been filed with the town clerk.

-Account balances as of September 19, 2023 for the general fund, highway fund, capital improvement fund, and street light fund have been filed with the town clerk.

-The earliest I could get concrete is the 6th of October. I have it ordered for 7:30 am and Andy wood is going to give us a hand pouring it. He has the tools to screed it off and finish it so that will be handy. Any other help will be much appreciated.

-We have \$24,000 left to come in for revenue to meet the budget, and there is 3 more months and one more sales tax check, so we are in very good shape. The sales tax checks have been running around \$120,000.

-Sales tax is \$32,374.00 more than I budgeted for.

-I have been working on the budget and hope to have a tentative budget ready for the board to review by the end of next week.

-Councilor Burnham asked what happened to the Fire Tax? Supervisor White stated he will check on it he does not think it came last year either.

- We had our 2022 Financial Audit and for the 5th year in a row they had no findings.
- The Emergency Service building has Prints/plans ready to go out to bids on Monday estimated cost \$5.6 million with no expense to the taxpayers.
- We passed a resolution opposing the Ammo Performance background check. Pistol permits went from a 5 year to a 3-year renewal.
- We passed a resolution opposing the issuance order for placing immigrants in St. Lawrence County. Massena airport hanger does not have the means to house them. According to ICE St. Lawrence County somehow got put on the list.
- We signed a contract with JJ Keller for highway driving training. 5 employees have finished the training and have their CDL's.
- Public Health put out a memo that COVID is on the rise. Wear a mask when needed, hospitals are requiring a mask again. If positive quarantine for 5 days. Stay up on your COVID vaccines because it is here to stay.
- Our budget review is done with county departments and budget is looking good. Sales tax is still coming in good.
- Supervisor White gave Larry our Local law #1 of 2023 pertaining to parking on all roads in Russell near guiderails.

We also put stone on the Silver Hill to Cook Road.

We installed a new 15" culvert on Silver Hill Road on the Crackerbox end.

We also did ditching as needed.

We have been screening sand for winter roads, we are about 80% done.

We have fixed shoulders and added crushed stone to all of the washouts from the rains this summer.

The trucks are all cleaned up and running.

The motor is rebuilt and being installed back into the Roller.

I spoke to Kevin Burke he will be paving our projects, they will be late but we should get them done before the end of the season.

I would like to thank the men for another safe and productive month.

The new plow truck is in assembly now, it has been 2 years.
