# LEGISLATURE REPORT: Larry Denesha

- Our Preliminary Budget will be reviewed on October 30, 2023.
- FMAT: all counties receive funding bur the Governor in her budget wants to keep it and not pass it along over the next 2 years; that means a increase of 3 million for St Lawrence County for medical costs.
- Lewis County has a double digit decrease this year.

- The Lazy River Bridge is on the 2024 bridge schedule; bids on the job will be done this month. 95% federal and 5% county cost. The work will start in the spring.
- We proclaimed October as St. Lawrence County History Month. All local historians were honored.
- We passed a resolution to support BillS1466. If someone was transported by ambulance Etc. they submit cost to insurance company and they cut a check to provider. This resolution will require insurance to remit money to the provider.
- We passed a resolution for NYS Governor to draft education for voters asking to enact to show ID to vote. This was passed 14 to 1 at the meeting.
- Remember when I told you that St. Lawrence County was on sanctuary list it is now removed from that list.
- Morris Jeffries asked where does all the money come from that the Governor wants? Larry stated your back pocket (Tax payers).

We installed the pump and water line at the pavilion and helped with the concrete pour. We also poured concrete and mounted the benches on the ball field by the old school.

The parking lot is finished also by the ball field at the old school.

We harnessed one truck for snow removal and will be getting all trucks ready within the next couple of weeks.

I talked to Glen Plaisted on our new truck, it is in the shop now and should be done within a month or so.

I am going down to TENCO SHOP tomorrow to see the progress.

We received a check for \$3,805.00 from Auctions International; I would like that amount put into the machinery account DA5130.4.

Joe Zachary did a safety inspection on 9/19/23 and found no safety concerns.

I would like to thank the men for another safe and productive month.

After reviewing the bids presented **Therefore**, the town Board will accept the bid from Northern Tier Contracting out of Gouverneur, NY for Project # 2 repair Chimney and Re-Pointing of the town Hall in the amount of \$59,500.00. The Money will be used from **ARPA FUNDS** to pay this.
